Terms of Service

1. Agreement to Terms.

By accessing or using SONAI's services (the "Services"), including the website, platform features, or any affiliated offering, you ("User" or "you") agree to be bound by these Terms of Service ("Terms"). If you do not agree, please do not use the Services.

You represent that you have the legal capacity to enter into these Terms. If you are accessing the Services on behalf of an organization, you affirm that you have authority to bind that entity, and "you" refers to both yourself and that entity.

2. Relation to Other Policies

Your use of the Services is also governed by our Privacy Policy and any supplemental guidelines (e.g. content rules, community standards). In case of conflict, these Terms prevail unless otherwise stated.

3. Changes to Terms

We may modify or update these Terms at our discretion. Any changes will be communicated through postings on the platform or direct notices. Continued use after changes signifies your acceptance. If you disagree, you must stop using the Services.

Because SONAI is evolving, features (including rewards, scoring, or algorithms) may be added, changed, or discontinued at any time without prior notice.

4. Who May Use the Services?

- You must be at least 18 years old (or legal age in your jurisdiction).
- You must comply with applicable laws, including export controls, sanctions, and anti-money laundering.
- You must not use VPNs, proxy services, bots, or other methods to mask identity for unfair advantage.

We reserve the right to suspend or block accounts, IPs, or addresses that violate these Terms or compromise platform integrity.

5. Service Features & Use

5.1 Connecting Social Accounts

- To use SONAI, you may link your X (Twitter) account or other supported accounts.
- Upon first connection, your Base Sonaize Score will be calculated as follows:

Score = w1·f(Followers) + w2·f(Posts) + w3·f(AccountAge)

Where f(x) applies logarithmic scaling to prevent KOL dominance. Weights w1, w2, w3 balance fairness across metrics.

5.2 Community Multiplier

Your final score may be adjusted:

Final Score = Base Score × (1 + Community Multiplier)

The Community Multiplier is dynamic, hidden, and influenced by peer engagement, collaboration, and authentic validation within the community.

5.3 Contribution & Rewards

- You may submit articles, memes, videos, or posts about projects.
- You retain ownership of your content, but grant Sonai a non-exclusive license to use, display, reproduce, and distribute it within the Services.
- Rewards (points, benefits, tokenized assets) may be earned based on contributions and your Sonaize Score.
- Sonai may withhold or adjust rewards if it finds abuse, fraud, or manipulation.
- Features under Beta Access may be unstable and subject to removal or reset.

6. Content Guidelines & Prohibitions

You agree not to:

- Post illegal, abusive, hateful, or infringing content.
- Use bots, scripts, or fake accounts to inflate metrics.
- Reverse engineer, hack, or tamper with Sonai's systems.
- Impersonate others or misrepresent affiliations.Spam, DDoS, or engage in fraudulent activity.

SONAl may monitor and remove violating content without prior notice.

7. Intellectual Property

- SONAI retains all rights, title, and interest in the Services, including software, trademarks, branding, and algorithms.
- Certain formulas (e.g., base score and community multiplier structure) are disclosed for transparency.
- Proprietary algorithms remain confidential and will be protected under IP certification.

8. Termination & Suspension

- SONAl may suspend or terminate your account if you violate these Terms.
- Upon termination, clauses on content ownership, liability, IP, and dispute resolution remain in effect.

9. Disclaimers & Risks

- Services are provided "as is," without warranties.
- Sonai does not guarantee uninterrupted availability or error-free operation.
- You are responsible for blockchain risks, wallet security, token volatility, and internet reliability.
- Sonai is not liable for losses due to user errors, third-party failures, or network issues.

10. Indemnification

You agree to indemnify and hold SONAI harmless from claims, damages, liabilities, or expenses arising from your use of the Services, content submissions, or violations of these Terms.

11. Limitation of Liability
